### **Essential Functions:**

- Follow the Kennolyn Appearance Guidelines.
- Be free of the influence of drugs and alcohol while on the property.
- Must be able to communicate verbally and in writing and be able to listen to or sufficiently comprehend camper/staff concerns.
- Ability to communicate one on one and to small and large groups
- Be ready to manage stressful situations effectively while thriving in a dynamic and interactive environment.
- Ability to walk over uneven terrain and work out-of-doors all day.
- We have an intentionally unplugged community. This means you should be comfortable with limited access to your mobile devices.
- Specific areas of expertise may have different requirements:
  - Group Counselors- may be required to: lead a hike of up to 4 miles in the forest in close contact with trees and dust.
  - Ropes Course Staff must be able to belay for extended periods of up to 2 hours with limited breaks.

- Waterfront Staff must be able to swim and pass required certifications.
- o Equestrian Staff-ability to spend long periods around horses and dust.
- Support Staff- ability to work in fast paced environment on your feet for multiple hours a day .

- Meet or exceed performance guidelines indicated at employment reviews
